## INFORMATION WE COLLECT AND HOW WE USE THE INFORMATION

### Information You Provide to Us

Generally, you may browse through the Sites without giving us any personal information about yourself. When you request information about our products, services, or events, you may voluntarily provide us with contact information, including your name, zip code, phone number and/or email address (“Information”). We use the Information that you provide to respond to your information requests regarding our products and services.

### Information You Post

Any comments or information that you post on public websites, including the Sites, is publicly available and may be viewed, collected and used by others, including TAV Networks. TAV Networks is not responsible for the privacy of any information that you choose to post on the Sites or for the accuracy of any information contained in those postings.

### Information Automatically Collected

Our cookies and other analytics technologies do not collect personal information and we do not combine the general information collected through cookies with other personal information provided to us to tell us who you are. We may use cookies, tracking pixels, or similar technologies or services such as Google Analytics to conduct analytics of our Sites. For example, we may automatically collect certain non-personal information from you such as your browser type, operating system, software version, Internet Protocol (IP) address, Internet service provider and platform types. We may also collect non-personal information about your use of the Sites, including the areas or pages of the Sites that you visit, the amount of time you spend using the Sites, the number of times you return, and other Site usage data. This information helps us to track and understand how visitors use our Sites, and improve the performance and user experience of our Sites.

## How We Respond to Do Not Track Signals

While most browsers will allow you to block cookies by enabling a Do Not Track header within the browser, our Sites do not recognize Do Not Track headers. However, we only use cookies as described in this Policy.

## ADVERTISEMENTS

We use third parties such as network advertisers to assist us in displaying our advertisements on third party websites, and to evaluate the success of our advertising campaigns. Network advertisers display our advertisements on third party websites based on your visits to our Sites as well as other websites. This enables us to target our advertisements for our products and services. Third party ad network providers, advertisers, sponsors and/or traffic measurement services may use cookies, JavaScript, web beacons (including clear GIFs), Flash LSOs and other technologies to measure the effectiveness of the ads they place for us and to personalize advertising content. These third party cookies and other technologies are governed by each third party's specific privacy policy, not this Policy.

You may opt out of many third-party ad networks, including those operated by members of the Digital Advertising Alliance ("DAA"). Also, if your browsers are configured to reject cookies when you visit the DAA's opt-out page, or you subsequently erase your cookies, use a different computer or change web browsers, your DAA opt-out may no longer be effective.

## INFORMATION DISCLOSURE

TAV Networks may disclose the information we collect from and about you as follows: (1) to our employees or third party vendors, agents, service providers or contractors, if the disclosure will enable them to perform a business, professional or technical support function for us; (2) to respond to legal process or provide information to law enforcement or regulatory agencies or in connection with an investigation on matters related to public safety, as permitted by law, or otherwise as required by law; or (3) as otherwise described to you at the point of collection.

Also, TAV Networks may sell or purchase assets during the normal course of our business. If another entity acquires us or any of our assets, information we have collected about you may be transferred to such entity. In addition, if any bankruptcy or reorganization proceeding is brought by or against us, then such information may be considered an asset of ours and may be sold or transferred to third parties.

## CONSENT TO TRANSFER INFORMATION TO THE UNITED STATES

Your information is stored on servers in the United States. If you are located outside of the United States, please note that information we collect will be transferred to and processed in the United States. By using our Sites, you consent to the transfer to and processing of your information in the United States, which

may not have data protection laws that provide the same level of protection as exist in the country where you reside.

## DATA SECURITY

TAV Networks has taken certain physical, administrative, and technical steps to safeguard the Information we collect from and about visitors to our Sites. While we seek to ensure the integrity and security of our network and systems, we cannot guarantee the security of the Information you transmit to us. We encourage you to take precautions to protect your personal data when you are on the Internet.

## LINKS TO OTHER WEBSITES

The Sites may contain links to other third party websites. Any access to and use of such linked websites is not governed by this Policy, but instead is governed by the privacy policies of those third party websites, even though some of these other sites may be co-branded with us and may look like Site features.
